

BRS Alpha/Ascension Licensing Programs



BRS has developed program opportunities to assist existing and new licensees to maximize roof panel manufacturing efficiencies while enhancing revenue growth possibilities for both companies.

What is an Ascension Licensee?

An Ascension Licensee is a new licensee who may not have the physical space, personnel, inventory, or the financial capital to own their production mill. The Alpha/Ascension program pairs up the manufacturing capabilities and inventory of the Alpha licensee with the new Ascension license holder. The symbiotic pairing relationship requires specific licensing addendums in addition to the Stand-alone Licensing Agreement including a written Certificate of Authorization from BRS to participate in the program. The symbiotic tied relationship with their Alpha manufacturer provides a valued steady client while adding revenue monies for the panel component purchases for the duration of the relationship.

What is an Alpha Licensee?

An Alpha licensee is a license holder that has rolling mill production capabilities, 24-gauge coil stock (white and galvalume) inventory, equipment, internal infrastructure, including the ability to manufacture, package their licensed panel profile as a component order purchase for a new Ascension licensee with the identical licensed profile. The Alpha acts as the manufacturing department for a new licensee called an Ascension license holder.
